2. OBJECTS OF THE TRUST:

(a) To spread education and for achieving the said object to establish, maintain, run, develop and improve, extend grant donations in cash, with kind and assist in the establishment, maintenance, running, development, improvement and extension of schools, colleges, workshops, Industrial and Technical Schools, institutions for the promotion of agriculture, hostels for the benefit of students, maintain agricultural farms for the benefit of the poor.

(b) To establish, maintain or acquire library or libraries for the benefit of the student community.

(c) To institute and award scholarships in India for the study, research and apprenticeship for all or any of the aforesaid educational purposes.

(d) To establish, maintain, run, develop, improve, extend, grant donations for and to aid and assist in the establishment, maintenance, running, development, improvement and extension of hospitals, clinics, X-ray plants, dispensaries, maternity houses, recreation centres and all similar institutions as will afford treatment to alleviate human suffering.

(e) To conduct poor feeding and generally give food and raiment to the poor, needy and disabled persons and to afford relief to people in distress due to natural calamities, accident, earthquake, flood, famine, epidemics and conduct or grant donations for the support of orphanages and welfare institutions.

(f) To provide food, shelter, clothing, medical care and education for the needy.

(g) To carry on community development programmes for the upliftment of the economically weaker sections of the society and also construct and develop community centres or halls for carrying on such activities.

### 3. PROPERTY VESTED IN THE TRUSTEES:

The Founder doth hereby transfer a sum of Rs.1,000/- (Rupees one thousand only) in favour of the trustees and unto the trustees thereof;

The Trustees shall hold the said fund and other properties that may be endowed or conferred for the said Trust for the use and benefit of the "KARPAGA VINAYAGA EDUCATIONAL TRUST".

The Trustees shall out of the income realised from the properties endowed and such other endowments or donations which they may get, pay all taxes and rates and all expenditure connected with the trust.

4. BOARD OF TRUSTEES:

(a) The Board of Trustees will ordinarily consist of not less than three and not more than nine members. The Founder and Author of the trust.

The trust may co-opt to the Board of Trustees, if necessary, to make the total number of nine.

(b) The trustees co-opted shall hold office only for three years and are liable for retirement. The trustees whose term of office expires after the period of three years, are eligible to be co-opted as trustees again by the existing trustees. The trustees may be if he so desired resign his trusteeship even before the expiry of the term of his trusteeship.

(c) The trustees shall appoint one among them as Managing Trustee of the Board of Trustees. Sri. S.VALLIAPPAN Son of Mr. A.N.S. Sevugam Chettiar, shall be the Managing trustee.

i. The trustees may frame rules and regulations as the duties and responsibilities of each trustee, to appoint sub-committees, mode of conducting any other matters connected with the administration of the Trust and its management.

6. CUSTODY OF DOCUMENTS:

The Managing Trustee or his nominee or any other trustee if so authorised by the Board of Trustees shall have the custody of all the documents, deeds of title relating to the trust properties and investment and the books of account and other records relating to the trust and shall be responsible for the preservation of the same.
